1. WG2 First Phase Work

The Chair of WG2, Angela Hull, outlined the work of the group in the first phase of the COST Action that was nearly completed and reminded WG2 that Report 1 had to be finalized by the end of March 2012 for editing and printing. The following sub-group managers explained the progress made since the last meeting in Edinburgh (October 2011) and the work that was outstanding:

- Accessibility Instrument Survey (Cecilia Silva)
- Report 1 Editorial team (Angela Hull)

2. Sub-Group Discussions

Each of WG2 Sub-groups met separately to discuss the work still to complete in the first phase of the Action. Sub-groups members identified the tasks to complete which were allocated to group members to complete within agreed timescales.

3. Feedback from Sub Groups

WG2 reconvened to listen to the feedback from each sub-group.

4. Discussion of Next Steps

Strategies for the completion of each chapter of Report 1 were discussed and action agreed. It was agreed that Sections 2, 3, and 4 should be completed by the end of March, allowing one month for the Preface and Conclusions to be written.

5. TU1002 Glossary

Angela Hull described the Glossary of terms that Action members had produced. It was agreed that more work was needed to improve the Glossary. Magda Mavridou volunteered to organise a week of discussion online between Action members to improve the existing definitions on the website and to extend the number of definitions of key terms posted.

6. Closing Remarks

Angela Hull thanked everyone for their positive approach to work in the first year of the Action and reminded everyone of the tight timetable to complete Report 1 for submission to the COST Office by the beginning of May/ June.
